Camp Use and Rules

Thank you for choosing to rent Parker Scout Reservation. Your rental helps to insure the future of the Central Minnesota Council's property here at Parker Scout Reservation. The Central Minnesota Council is glad your group has chosen to rent Parker Scout Reservation. To insure, Parker Scout Reservation property stays in the best condition the Central Minnesota Council asks that your group abides by the Councils policies for rentals.

The following activities are not permitted at any time:

- ➤ No illegal activities
- > No destruction of camp property including carving or writing names in bunks, walls, or trees
- ➤ No use of fireworks
- > No use of flammable liquids
- No gum
- No glitter except in the Activities Center
- ➤ No ATVs or UTV's
- ➤ No alcoholic beverages or illegal drugs
- Smoking is only permitted in the Admin Parking Lot
- ➤ No Pets
- ➤ No cutting of standing trees or brush
- ➤ No harassing or hunting of wildlife
- No firearms or weapons

Trash and recycling are to be placed in the designated bins near the Dining Hall. **Do Not** bag recycling!

Fires are only to be burned in the provided fire rings such as Council Fire, Family Camp or campsites. Never leave fires unattended. Use water to extinguish fires and make sure they are out before leaving. No open flames are allowed in tents, use only flashlights or battery lanterns. Flammable liquids are not to be used to start a fire.

Pets are not permitted at Camp unless they are trained and certified Service Animals. Emotional Support animals are not considered Service Animals.

The ranges are only available for use (extra fees apply and times with the councils certified staff may be arranged) per the guidelines of Scouting America.

Fishing is permitted at Parker Scout Reservation. All fishing must be done in accordance with current regulations of the State of Minnesota. Those 16 years of age or older must possess a current Minnesota State Fishing License.

Swimming beach is available for rent. The use of the swimming beach must be done under the supervision of certified Lifeguards. Certification must be sent to the Council office before using the swimming beach.

Equipment is available on a limited basis. All equipment must be returned in acceptable condition. Arrangements for equipment must be made in advance and paid for to assure availability.

The camp speed limit is 10 mph. Each passenger must use a seat belt. Absolutely no passengers in the back of trucks or on trailers. All vehicles are to remain on the road or in designated parking areas.

Golf Carts may be used on the camp trails as long as the drivers are trained and on the list of acceptable operators.

Troop Trailers may be taken to campsites and left there for the duration of your outing. Campers and motors homes are only allowed in the Family Camp area.

No blocking of roadways and driveways. Park in designated areas. Fire and medical personnel must be able to get around camp.

Renter agrees to the above policies and understands that any violations of the policies will mean the forfeiture of the deposit and paying any associated costs created by the violation.
